## Stable Rules

In order to maintain safety for all riders and horses, and as well to maintain cleanliness throughout the stable grounds. The following rules must be followed. All riding and handling is done at your own risk!

- 1) Cigarette, cigar, and pipe smoking are prohibited under the roofs of the barns upon arrival please extinguish.
- 2) We recommend that halters be removed from horses in stalls and turnout areas. IF halters must be left on breakaways will be required.
- 3) No horse is to be left unattended, tied in its stall or on crossties.
- 4) ASTM/SEI hard hats are required at all times when riding. Boots or riding shoes with heels are required at all times when riding.
- 5) No unattended children are allowed. Children are not allowed at the barn without adult supervision until they reach the age of 13.
- 6) Children under the age of 13 are not allowed to handle or ride any horse on the premises unless supervised by an adult.
- 7) There will be no riding in the barns at any time.
- 8) Do not block doors and alley ways, except when your horse is in crossties.
- 9) All owners, riders, and blacksmiths must clean up after themselves, only dump manure in designated areas.
- 10) Lock the tack room/office prior to leaving the property if no one else is around. Any loss of equipment is not the responsibility of the stable.
- 11) All horses must be washed in designated washing areas. Water hoses should be recoiled tightly when you are finished with them.
- 12) In an emergency a vet will be called at your expense if you cannot be reached or if you fail to take appropriate measures.
- 13) Please be sure to have on file at the stable office
  - a. Signed Stable Rules
  - b. Signed Release / Hold Harmless
  - c. A signed board agreement and current medical records of the boarded horse
- 14) Any unnecessary reprimanding of any kind such as: abusive spurring, gross neglect or harmful training methods to include drugs or injury, will not be tolerated by this establishment.
- 15) No pets are allowed.
- 16) All visitors will be expected to follow all the rules of the facility.

- 17) Board and rent is due the first of the month and is considered late if not received by the 5<sup>th</sup> of the month. Legal action will be taken after 60 days.
- 18) Any concerns and requests must be addressed in writing with your name and date placed on the request. Please leave these requests in the office.
- 19) Boarders are required to check with management before making stall or tack room changes.
- 20) Area courtesy should be recognized at all times. When riding on the rail pass left shoulder to left shoulder.
- 21) No transfers, refunds or exchanges.
- 22) If a payment is received late it is subject to a \$25 late fee charge.
- 23) If paying by credit card there is a 3% merchant fee.
